- **YOU WILL HAVE TO WAIT LONGER FOR FIRE ENGINES TO GET TO YOU IN EVENT OF A FIRE**
- **YOU WILL BE EXPECTED TO WAIT FOR LONGER TO BE CUT FREE FROM A CAR CRASH OR OTHER SIMILAR INCIDENT**
- **YOU ARE EXPECTED TO BE HAPPY WITH HAVING FEWER FIREFIGHTERS ARRIVING AT AN INCIDENT AND EVEN FEWER AVAILABLE AT NIGHT WHEN YOU AND YOUR FAMILY ARE MOST AT RISK**
- **YOU WILL HAVE NO SAY AT ALL IF YOUR LOCAL FIRE STATION IS CLOSED AS HE PLANS TO TAKE THIS RIGHT AWAY FROM YOU**
- **YOU WILL HAVE NO RIGHT OF APPEAL IF LOCAL FIRE ENGINES AND FIREFIGHTERS ARE MOVED MANY MILES AWAY**
- **YOU WILL PAY MORE FOR SERVICES AND INSURANCE PREMIUMS IF HIS PLANS GO THROUGH**
- **YOU LIVE IN AN AREA WHERE DESPITE MR PRESCOTT'S OWN GOVERNMENT STUDY SAYING YOU SHOULD HAVE AN INCREASE IN THE FIRE COVER YOU GET, HE IS GOING TO SIGN IT AWAY AND MAKE REDUCTIONS. WHEN WERE YOU ASKED?**
